

Sergeant Bell was working with "D" Company in search & Clear operations near the Nui Mieu Mountains along the South China Seacoast of Binh Dinh Province. Bell was an Engineer Specialist in EOD from the 1st Cavalry Division's 8th Engineers. At approximately 9 AM the Armored Personnel Carrier on which Howard Bell road hit a pressure detonated land mine, resulting in his death. 3 others were wounded, one from fragmentation as a result of the blast and two suffered concussions.

Former "D" Company Medic, Robert Melendez, witnessed the event that day and so informed the Association.










THROUGH HIS UNTIRING EFFORTS AND PROFESSIONAL ABILITY, HE CONSISTENTLY OBTAINED OUTSTANDING RESULTS. HE WAS QUICK TO GRASP THE IMPLICATIONS OF NEW PROBLEMS WITH WHICH HE WAS FACED AS A RESULT OF THE EVER-CHANGING SITUATIONS INHERENT IN THE COUNTERINSURGENCY OPERATION AND TO FIND WAYS AND MEANS TO SOLVE THOSE PROBLEMS. THE ENERGETIC APPLICATION OF THIS EXTENSIVE KNOWLEDGE HAS MATERIALLY CONTRIBUTED TO THE EFFORTS OF THE UNITED STATES MISSION TO THE REPUBLIC OF VIETNAM TO ASSIST THAT COUNTRY IN RIDDING ITSELF OF THE COMMUNIST THREAT TO ITS FREEDOM.
