The truth behind the story of

AGENT ORANGE

Even though the Vietnam War ended, it continues to rage in the hearts, the minds, and the bodies of many veterans. One reason is an herbicide called, "Agent Orange". A few years after the end of the conflict, veterans began to develop certain health problems. Eventually, a possible link was made between the veterans, their medical conditions and exposure to Agent Orange.

Agent Orange (named after the orangestripped barrels in which it was shipped) was one of several chemicals used to kill vegetation that provided cover for our enemy. In 1971, it was discovered that the herbicide contained dioxin, an unwanted chemical-by-product created during the manufacturing process. The type of dioxin in Agent Orange is thought to be harmful to humans. In 1978, the Department of Veterans Affairs began the Agent Orange Registry Examination Program. The registry is an attempt to identify and record information about veterans who served in Vietnam. The data gathered is used to study health trends among the group.

"The registry exam does not mean a veteran is automatically entitled to benefits," cautions Dr. Mather, Chief Public Health and Environmental Hazards Officer for the VA, "but the data gathered may be used in filing for benefits." To date, approximately 10 percent of those who served in Vietnam have registered.

Each VA medical center has an Agent Orange coordinator to assist veterans with registering and filing for benefits. The coordinator serves as the veteran's point-of-contact at the medical center for Agent Orange issues. The coordinator can schedule the exam and help the veteran pull together the documentation needed to apply for benefits. The coordinators are also up-to-date on information regarding Agent Orange research and benefits.

Currently, VA offers priority medical care to veterans with health problems that may have resulted from Agent Orange exposure and recognizes ten diseases as being service-connected. Contact your local VA Office for additional information on those listed diseases.

"The Agent Orange issue is not a closed book," says Dr. Mather. Research continues into other possible heath effects of exposure to the herbicide. If you are concerned of a possible exposure to Agent Orange, contact the Agent Orange coordinator at your nearest VA medical center. Lest We Forget

This article is being reprinted from another Veterans source.

"I saw you writing something," a man said as he approached me after a showing of the documentary, *Return with Honor*. "I hope," he continued, "you include that only 24 people showed up to see this film!"

Return with Honor is 102 minutes of memoirs of several captured pilots imprisoned in North Vietnam during the Vietnam Conflict. In Return with Honor, POW remembrances are juxtaposed against Hanoi's archival footage of their captures and interrogations. Frame after frame cross the screen. The film bears witness of the will of the American flyers to survive their captors treachery and to return to the families and country they loved. Most were locked away for years at the notorious Hoa Lo Prison, forever dubbed "The Hanoi Hilton." Today, the prison is deserted. Yet it remains literally a city block of 13 foot stone walls, broken glass bottles embedded in them, topped off with high-tension wire. The now empty cells were then infested with rats; in each tiny cell was a one-bed board with concrete supports, while rusted leg irons protruded from the crumbling cement walls.

The pilot who suffered the longest at the Hanoi Hilton was Ev Alvarez, who holds the distinction of being the first airman shot down by the NVA on August 4, 1964. As the first, Alvarez today feels that neither he nor his captors knew what to make of the situation in the beginning. "In the initial days, it was an experience to me and for them. I don't believe they really knew what to do. They asked us why we didn't answer their questions. And I would tell them that I was a POW and according to the Geneva Convention, I am not supposed to. But they would tell me, you are not a POW cause this was not a war."

Said 1st Lt. Leroy Stutz, "I was the toughest fighter pilot in the world: John Wayne and Superman all rolled into one. I found out real fast how weak I really was. The pain may have cleansed me. But it hurt when my shoulders rotated in their sockets and I was hanging there. I bled. I prayed. I screamed and when I screamed, all they did was stuff a dirty old rag in my mouth. The thing that affected me most was thinking, God I don't want to die here, nobody would ever know."

"We were tortured to give them something," said Jeremiah Denton, "But we didn't give them anything. We made them torture us again. We gave them as little as we could each time. The idea was to return with honor."

To the Vietnamese, the POW's were an extension of the anti-war movement. The Vietnamese people knew they could not compete on the battlefield. When the American people got the idea of what this war was about, they lost interest. They withstood attempts at coercion by developing a survivor's mentality accompanied by a code that included tapping on walls and blinking Morse Code with their eyelids before the world's press when they knew footage would be aired at home.

According to the filmmakers, it was Ho Chi Minh's intention to brutalize the pilots. After his death in 1969, the POW's treatment improved. But it was not enough to make up for what they endured and still live to this day. Hopefully, more than 24 people will never forget that!

PROMISES

Someone once said that as we age, three things begin to fail. The first is memory, yet no one seems to remember what the other two are. Indeed, some of life's events may be simply too painful to remember and we subconsciously suppress them. Still, remembering is an essential part of living, and for Americans, it is part of our heritage. Remembering who we are, where we came from, how we arrived at this point in our history is worthy of reflection. After all, we are Americans and, as a community of veterans, we share in the responsibility to remember and to remind those who may have forgotten, that freedom is not "free". The cost is measured, not only in terms of lives lost and sacrifices made, but also in terms of commitment by millions of men and women who have worn this nation's uniform in defense of our way of life. For us, remembering is a celebration honoring those Americans who have answered their nation's call. I think we would agree that freedom's costs have not been too great for the value received.

Nevertheless, at a time in our history when Americans are enjoying unprecedented prosperity; where employment opportunities seem plentiful; and where the threat of international conflict is relatively low, too many of our citizens seem to have forgotten how we, as a nation, arrived at this point. They take freedom for granted. Within our military, personnel recruiting is down, retention is down, force readiness has significantly declined. Many men and women in uniform qualify for food stamps, while serving in defense of their country. In less than a decade, we seemingly have dismantled our national defense posture to the point where the risk of conflict could once again evolve. Within the veteran community we have watched as a "grateful nation", through the actions or inaction of our elected officials, has failed to provide the health care and benefits promised to those who served. We remember the promises. Now, we need to continue to remind our congressmen and senators that they have a sacred obligation to honor those commitments.


FROM THE CHAPLAIN



To be sure, this past quarter has been my busiest as your Historian. I am happy to report that Ray Sarlin has accomplished much in the documentation of our Regimental History, as well as complimenting a growing Database of our Battalion's men who were killed in action. My thanks to Ray for his assistance!!

As a direct result of Ray's assistance in the Unit Lineage, I have been free to obtain quite a few new documents from the National Archives at College Park, Maryland. Just today I have finished scanning ail of my complete documents including After Action Reports, Daily Staff Journals, Quarterly "Histories", etc. In all, I have scanned 1,261 pages! The Microsoft Access Database of the entire collection is available to any interested member. I will also mail a brief descriptive listing to anyone who does not possess one of the confounded computers.

I plan to have 2 large file cases full of "hard copy" documents at the reunion. I also will have Compact Disks (CDs) available for sale complete with Battalion & Infantry logos containing copies of all of our documents in Adobe Acrobat Format*. (These will be available at a very reasonable price with a small profit going to our treasury). I have already sent some samplings of these efforts to several of you and have gotten great feedback. I shall include on each disk the Acrobat Reader which will allow you to read as well as print all documentation from your personal computer.

I shall be visiting the National Archives on a regular basis. Anyone who has a specific time frame of interest should feel free to inquire about obtaining copies of documentation.

West, Clarence: Clarence served in Delta Company from May of 1968 until April 1969. He currently resides in Texas.


