

#### The Bonds of Combat.

When do men "learn" not to cry in emotional situations? When do men "learn" that it is not manly to say "I love you" to another man? When do men "learn" that it is not macho to hug another man? Somewhere in a man's life they "learned" these things even though they weren't taught to them by anyone.

Have you ever seen men who have been in combat reuniting with their combat buddies? There are a lot of tears and hugs. Watch the movie <u>Saving Private Ryan</u> and you will see an honest portrayal of the emotions of men who have been in combat together.

This is a story about Donald Morrison, one of many combat buddies, and the lessons about the bonds of combat that they taught me without realizing what they were doing. Donald was selected not to slight anyone but rather as the personification of this bond. Because this bond is so special you cannot discuss it in general but rather in terms of a person. Those who have served in the Armed Forces understand the bond of friendship. However those who have served in combat together have carried this bond to a higher level. It is an emotional link that goes beyond friends, family and loved ones.

When the bullets are flying in combat there is an immediate reaction within your being called fight or flight. Military training overcomes the flight part and teaches you to react by staying and fighting. All emotions are suppressed until the battle is over and then you move on to your next mission. In between you deal with the emotion inwardly or try to forget about it. Combat is one place where men learn to suppress their emotions. Many of them do such a good job of it that it becomes a habit that they carry throughout life until they are reunited with their buddies from the war.

There are many Donald Morrisons in the world and I was fortunate to have served with many

of them in Vietnam. What makes these men so special? Did they save my life? Not directly. Did they perform some heroic act? None that would have warranted a medal. They were just ordinary citizens from your hometown who were asked to do a dirty job. They did the best they could and then they went on with their lives as though what they had done was expected of them. They didn't ask for medals, parades, fanfares nor media attention. They just wanted to go home and forget the war. Many did such a good job of this that they put the names and faces of their combat buddies in the far reaches of their minds.

It is often said that the most dangerous weapon in the world is a second lieutenant with a map and a compass. I think I personified that description. However, all of my Donald Morrisons helped me look good because they could read a map and knew the tank trails of Fort Hood, Texas. If it weren't for them I would still be lost on Fort Hood. In Vietnam they made me look even better because we were not a platoon of individuals but rather a cohesive combat unit. Being in combat is a thankless job. Being a leader in combat is even worse because you have to get these men to perform horrific acts, such as assaults, in the face of bullets. Because these men did their job so well it made being a leader a little less agonizing than what it could have been.

I, like so many people, came back from the Vietnam War and forgot about it. I closed the door on it and never looked back. I put the names and faces of all of the Donald Morrisions in the back of my mind but never really forgot about them entirely. I never knew if these men had made it back alive and really didn't want to face the possible bad news.

In October 1997 I was contacted by Ken Riley, another member of the battalion (1st Battalion 50th Infantry Mechanized) that I had served with. He had started an association for those who had served with the unit. My first question to Ken Riley was: did he have the address and phone number of Donald Morrison? He did and I immediately called Donald.

His wife, Connie, answered and told me that he had just returned from the hospital after cancer surgery on his leg. She said he as sleeping so I talked with her at length. I told her how special Donald was to me and I had thought about him for years even though I had not thought about anything else associated with Vietnam. The next evening I called and finally got to talk to my combat buddy.

I called him once more and we were making plans to see each other at the reunion in September 1999. Regretfully I never traveled to Georgia to see him. I didn't think there was a need. He made me feel that everything was all right with him. That was the way he was.

In February 1999 I received the worst letter I could ever receive. Donald passed away on January 30, 1999. Donald Morrison may be gone but he lives on in all of us who share the bond of combat.

There is a lesson here. If you care for and, yes, even love another person, tell him. If you have been thinking about them, tell them. Don't wait another day, hour or minute. None of us are guaranteed tomorrow even though we take it for granted.

Thank you Donald Morrison for: teaching me that it is all right for a man to express his true feelings and emotions; teaching me that it is OK to hug your combat buddies, cry and tell them that you love them; helping me experience the bond that people in combat share; and being the inspiration for this story so that others may know the bond of combat.

I salute you Donald Morrison and the officers and men of the 1<sup>st</sup> Battalion 50<sup>th</sup> Infantry. I salute all of the brothers in combat. Please tell your brothers how you feel before it is too late and all you can do is tell their story.

Even though the bond of combat is strong it is nothing to hope for. I hope that you who read this story do not have to experience combat. It is not glorious but painful and emotional.
