As editor of this newsletter, I wish to invite each and every member of the association to send me anything they feel would be an up scale note for all members to read.

This story was sent in by Norm Poage, and although it has nothing to do with our battalion, I found it interesting enough to put here.

HOW MIL SPECS LIVE FOREVER...

The US standard railroad gauge (distance between rails) is 4 feet, 8.5 inches. That's an exceedingly odd number. Why was that gauge used? Because that was the way they built them in England and the US railroads were built by English expatriates.

"They" use that gauge then because the people who built the tramways used the same jigs and tools they used for building wagons, which used that spacing. Okay! Why did the wagons use that odd wheel spacing? Well, if they tried to use any other spacing the wagons would break on some of the old, long distance roads, since that's the spacing of the old wheel ruts.

OK! Who built the old rutted roads? The first long distance roads in Europe were constructed by Imperial Rome for the benefit of their legions. The roads have been used ever since. And the ruts? "TEARS OF BLOOD", written by Chuck Lawrence, is a betrayal of American Veterans. Chuck, like so many of us who proudly served our country in Vietnam, was greeted by bureaucratic service structures like the US Department of Veterans Affairs which were unresponsive and difficult to deal with. The USDVA did not fulfill its role of veterans advocate as mandated by law. Chuck has written a compelling story of his experience He does a masterful job of identifying where this with the USDVA. lethargy on USDVA's part impacted his entire life, causing him even a greater amount of trauma than did his service in Vietnam. It is a descriptive analysis that lets us know that all too often our tax dollars are misused. The book identifies the problems in this system. It suggests positive solutions to correct them. Chuck highlights his failures in dealing with the VA in an effort to help others avoid the same mistakes. The book sends out a clear message to all in that it explains in detail why some veterans have become hostile in our society. TEARS OF BLOOD goes beyond the maladies brought on by war and focuses on how those situations build on problems like FTSD and other war related traumas. It provides an avenue for self healing for all veterans who have experienced not only the hardships of combat, but the difficulties associated with accessing the VA system. The narrative is clean, direct, and causes the reader to experience the full range of emotions in a roller coaster fashion.



It seems that a career soldier who was injured in combat receives compensation for that injury. When they retire however, compensation paid to them for a service connected injury is deducted from their retirement pay. In no other occupation throughout this country does that happen except in the military.

There is a bill, H R 303, presently in congress to revise that. It

states in part:

To amend title 38, United States Code, to permit retired members of the Armed Forces who have service-connected disabilities to receive compensation from the Department of Veterans Affairs concurrently with

retired pay, without deduction from either.

Not being either disabled or retired military, I have to say this does not effect me. However, I know there are plenty of you out there who know someone, maybe yourself, who is or will be effected by this. It seems to me that all veterans should stand up and speak out on this issue, to get it resolved now, before the bill is again deadlocked by our congressmen. WRITE YOUR CONGRESSMEN.

#### TIDBITS


